In addition, the proposal must also be made in good faith, taking into account the interests of the Company, is an agenda that requires the approval of the GMS, includes reasons and materials for the proposed agenda for the Meeting, and does not conflict with the provisions of laws and regulations and the Company's Articles of Association.
